Going Home 2018 Advocacy Days

Governor Call In Script



1. Call Governor Rauner's office at 217-782-0244. If you prefer to use a TTY, call 888-261-3336
2. Say: "My name is _____ and I am from _____ (city/town in Illinois). I am a _____ (identify why you care about this issue or how you are connected – self-advocate, ally, staff, family member, friend, etc.)."
3. Say: "As the Governor of, I am asking you to meet with the Going Home Coalition to discuss:
 - 'Closing 5 by 2025' to reduce Illinois' overreliance on supporting people with intellectual and developmental disabilities in state institutions. We would like all state institutions to eventually close, but we would like to start with decreasing from 7 centers to 2 centers by 2025; and
 - Rebalancing the Illinois system by moving dollars away from state institutions to community living."
4. If you get a person who asks you questions, say the following:
 - "More than 19,000 people with intellectual and developmental disabilities in Illinois are actively waiting for services"
 - "1,685 people with intellectual and developmental disabilities are living in state institutions"
 - "Illinois ranks 47th nationally in funding services that promote community inclusion"
5. Thank the Governor for listening to your message.

HCBS GUIDE: SUPPORTING THE RIGHT TO A COMMUNITY LIFE



The Home and Community Based Services (HCBS) Settings Final Rule announced by the Centers for Medicare and Medicaid Services (CMS) in January 2014 to make sure that people with disabilities have the kinds of services they need in their communities. The Rule sets requirements for where and how Medicaid HCBS are provided to ensure that people receiving services through Medicaid HCBS waiver programs have full access to community life. This means that services should be provided in the most integrated setting possible, and must provide opportunities for integration and access to the community, choice, individual rights, and independence.

Throughout the planning and implementation process to comply with the Rule, states will ask stakeholders for input about the services they receive, the places where services are provided, and changes that could be made to help them get the community lives they want. Some people with developmental disabilities may need assistance to think about how their services could better support them in their communities and to advocate for their right to a community life.
