#### **Self-Advocacy Is Worldwide!**

On March 26, 2014, self-advocates from ROHSA, along with ROHSA advisor Leanne Roth and Alliance Community Organizer Tara Wickey, spent time with a group of professionals from NHS Lothian and Edinburgh City Council in Scotland who came on a study visit to Chicago.

The group works with and provides services to people with developmental disabilities (called learning disabilities in Scotland) and their services are going through a period of redesign. In addition to meeting with self-advocates and The Alliance, the group also met with other agencies and organizations in the Chicago area. Not only did the group gain information, they also took back self-advocacy resources that they can use to support people with developmental disabilities in Scotland.
