#### The Alliance Welcomes Kimberly Mercer-Schleider as the new director of the Illinois Council on Developmental Disabilities!



Director Mercer-Schleider was recently interviewed by Alliance Self-Advocate Leader Kimberly Estes.

#### Where to do want self-advocacy to be in 5 years?

I hope policy makers are asking individuals with disabilities what they think about policies, rather than asking other groups. I want to see self-advocacy groups that are organized to be more present to speak to legislature. I want the first thing legislators think when making policies is to talk to advocates. Illinois should have more self-advocates be empowered and to stand up for what's important; also reaching out to self-advocates to help them find advocacy groups.

#### What are your specific plans regarding self-advocacy for the next year?

On behalf of the Council on Developmental Disabilities, I will continue to fund the Alliance so we can reach our goals and continue to have good group leaders. I also want to understand how other states are organizing their self-advocacy groups to see some things we might want try...things that have worked for the groups.

#### What did you do before you took this position and do you like your new role?

I was a Transition Manager for Chicago Public Schools. There are 22,000 students with disabilities in high school alone in Chicago Public Schools. I enjoyed that work, but when this new position came up it was something that I am passionate about. Regarding how she likes her new role, "I love it!" "I have learned so many things and am excited to put all the pieces together. It brings everything together that I care about working with self-advocates."

#### What is your college degree?

Bachelors in Special Education Master in Special Education Master is Non-profit Administration Laughing, she also said, "and a lot of student debt."

#### Do you have experience working with self-advocates?

"I do. I have worked a lot with individuals with disabilities when I was a teacher at the Center for Independent Futures." I helped people move into apartments so they could have more independence. While at Chicago Public Schools I advocated for individuals to speak up at the own IEPs.

#### Just for fun....do you like game shows?

"I absolutely love game shows." I also like Family Feud and Wheel of Fortune, and reality competition shows like the Voice.

#### How long do you plan to stay in your current position?

"As long as they will have me. There's a lot of work to do...enough work for me and 20 of me to do."
